Article (1)

Granting the Capacity of Judicial Officer

Employees of Advocates and Legal Consultants Affairs Directorate, whose names and designations are stated in table attached to this Resolution, shall be granted the Capacity of judicial officers to evidence actions committed in violation of the provisions of the following Legislation and resolutions issued by virtue of such Legislation, referred to hereinafter as the "Legislation":

- The aforementioned Executive Council Resolution No. (22) of 2011; 1.
- The aforementioned Administrative Resolution No. (51) of 2022; 2.
- 3. The aforementioned Administrative Resolution No. (52) of 2022; and
- The aforementioned Administrative Resolution No. (53) of 2022. 4.

Article (2)

Duties of Judicial Officers

Pursuant to Article (1) of this Resolution, employees granted the capacity of judicial officers shall comply with the following:

- 1. Provisions of Legislation and observing stipulated procedures when they perform their duties;
- 2. To verify compliance of those addressed by provisions of Legislation including advocates and legal consultants registered with the Department with the duties imposed on them by virtue of such Legislation and ensure that they do not violate these provisions;
- 3. To record violations assigned to investigate and collect relevant information and evidence pursuant to legislation in force and applicable procedures in this regard;
- 4. To receive reports and complaints concerning violations relevant to their jobs pursuant to the approved procedures in this regard;
- 5. To take the necessary procedures and measures to maintain all evidence relevant to the committed violation;
- To draft record of facts and actions taken by them; 6.
- 7. To observe integrity, honesty, impartiality and objectivity;
- To present proof of their capacity when performing the duties assigned to them; and 8.
- 9. Not to misuse the capacity of judicial officer to achieve personal interest or benefit.

Article (3)

Powers of Judicial Officers

Employees granted the capacity of judicial officers shall exercise the following powers by virtue of Article

- (1) of this Resolution:
- 1. To seek the assistance of police, when required;

- 2. To seek the assistance of experts and translators, when required;
- 3. To hear and record statements of witnesses and those who file reports; and
- 4. To conduct inspection, ask questions and clarifications and enter into authorised places to collect information relevant to the committed violation.

Article (4)

Executive Procedures

The Director of Advocates and Legal Consultants Affairs Directorate shall take the necessary actions for implementing the provisions of this Resolution, including:

- 1. Coordination with the relevant Organisational Unit of the Department for the issuance of identification cards of judicial officers under the provisions of Article (1) of this Resolution; and
- Approval of violation order forms including essential information in compliance with the provisions of the aforementioned Law No. (8) of 2016 and its implementing bylaws.

Article (5)

Commencement and Publication

This Resolution shall come into force on the date of its issuance and shall be published in the Official Gazette.
