



# Administrative Resolution No. (105) of 2017 Amending Certain Provisions of Administrative Resolution No. (233) of 2015 Adopting the Bylaw Concerning the Registration of Advocates in the Emirate of Dubai\*

## The Director General of the Government of Dubai Legal Affairs Department,

After perusal of:

- Law No. (32) of 2008 Establishing the Government of Dubai Legal Affairs Department;
- Executive Council Resolution No. (22) of 2011 Concerning Fees and Fines Prescribed for the Advocacy and the Legal Consultancy Profession in the Emirate of Dubai, and
- Administrative Resolution No. (233) of 2015 Adopting the Bylaw Concerning the Registration of Advocates in the Emirate of Dubai,

#### Does hereby issue the following Resolution:

### Article (1)

Article (12) of the Bylaw Concerning the Registration of Advocates in the Emirate of Dubai annexed to the above mentioned Administrative Resolution No. (233) of 2015 shall be replaced by the following:

#### Article (12)

a. The Advocate may not practise the advocacy profession in the Emirate unless he/she takes the following Oath:

"I solemnly swear by Almighty God, to perform my duties in accordance with the legislation in force in the Emirate of Dubai, to safeguard my client's rights honestly and faithfully and to uphold the traditions and ethics of the advocacy profession".

b. Before proceeding with advocacy work, the Advocate approved for pleading before the Cassation Court shall take the Oath before any of the circuits of the Cassation Court. The

Oath of the Advocate approved for pleading before other courts shall be taken before any of the circuits of the Appeal Courts.

c. Taking the Oath shall be documented in minutes, a copy of which shall be kept in the Advocate's file in the Department.

## Article (2)

This Resolution shall come into force from the date of its issuance and shall be communicated to persons concerned to put it into effect.
