**Does hereby issue this Resolution:**

**Article (1)**

**Formation of the Committee**

**"The Committee for Reviewing Grievances related to the Advocacy and Legal Consultancy Profession in the Emirate of Dubai "** will be formed in the Department **under the chairmanship of the Director General** and the membership of:

## Article (2)

### Functions of the Committee

- A. The Committee will decide on grievances submitted against the procedures and decisions of the Department based on the provisions of the aforementioned Executive Council Resolution No. (22) of 2011 and the bylaws issued by virtue of that Resolution, related to the regulation of the advocacy and legal consultancy profession, in accordance with the legislation in force in the Emirate of Dubai.
- B. The decisions issued by the Committee will be final.

## Article (3)

### Administration of the Committee

- A. The Committee will hold its meetings at the invitation of the Chairman or the Vice Chairman in the event of the absence of the Chairman, whenever it is deemed necessary.
- B. The meetings of the Committee will be valid by the presence of all its members provided that the Chairman or the Vice Chairman is present.
- C. The Committee will issue its decisions by majority vote of its members. In the event of a tied vote, the Head of the meeting will have the casting vote.
- D. The Committee decisions will be recorded in minutes of meetings to be signed by the Head of the meeting and the members in attendance.

## Article (4)

### Rapporteur of the Committee

The Committee Rapporteur will invite members to attend Committee meetings, prepare the agendas for Committee meetings, record minutes of meeting for the Committee, follow up on the implementation of Committee decisions, and fulfill any other task assigned to him by the Chairman of the Committee.

**Article (5)**  
**Revocation**

This Resolution will replace Administrative Resolution No. (50) of 2017.

**Article (6)**  
**Validity**

This Resolution will come into force from the date of its issuance and shall be communicated to whomever is necessary for its implementation.
