



Administrative Resolution No. (28) of 2025 **Appointing Members of the Professional Conduct Committee** of Advocates and Legal Consultants

The Director General of the Government of Dubai Legal Affairs Department,

After perusal of:

Administrative Resolution No. (54) of 2022 Concerning the Regulation of Disciplinary Accountability of Advocates and Legal Consultants in the Emirate of Dubai; and

Administrative Resolution No. (4) of 2025 Appointing Members of the Professional Conduct Committee of Advocates and Legal Consultants,

Does hereby issue this Resolution:

Article (1)

Appointing Members of the Committee

A. The "Professional Conduct Committee of Advocates and Legal Consultants", referred to hereinafter as "The Committee", shall be comprised as follows:

- B. The Committee shall consist of one or more subcommittees. Chairperson, Vice Chairperson and members of each subcommittee shall be appointed by virtue of a resolution issued by the Director General.
- C. Each subcommittee shall perform duties and functions of the Committee pursuant to the rules and provisions stipulated in the aforementioned Administrative Resolution No. (54) of 2022.
- D. Membership of the Committee shall cease on the 31st of December 2025. Members of the Committee shall continue to perform their duties if a resolution to re-appoint the members has not been issued by the Director General of the Department.

Article (2)

Organizational Duties of the Committee

Without prejudice to Committee duties and functions, as stipulated in Articles (9) and (10) of the aforementioned Administrative Resolution No. (54) of 2022, performed through subcommittees of the Professional Conduct Committee as mentioned in this Resolution, the Committee shall regulate its subcommittees work procedures in a manner that maintains proper workflow of these subcommittees and expeditious decisions on violations considered before them pursuant to the processes and procedures approved by the Department in this regard.

Article (3)

Delegation of Committee Members

- A. The Committee Chairperson or Vice Chairperson may delegate a Committee member to the membership of any subcommittee of the Professional Conduct Committee to achieve the quorum for the purpose of completing the subcommittee formation and validity its meeting.
- B. Once they are informed that it will not be possible to hold the subcommittee hearing for not achieving the quorum for holding that hearing, the Chairperson or Vice Chairperson of the relevant subcommittee should immediately notify the Chairperson of the Committee and Advocates and Legal Consultants Affairs Directorate of the same and mention the reason.
- C. Chairperson or Vice Chairperson of the Committee shall appoint the delegated member and determine the duration of such delegation.
- D. The delegated subcommittee member shall undertake their duties in addition to other duties assigned to them as a member of their subcommittee.
- E. Chairperson of the Committee should observe the number of delegation for each Committee member, create a list on delegation cases and state the name of the delegated member, date and duration of delegation and the subcommittee where they are delegated.
