



Administrative Resolution No. (31) of 2025 Forming the Committee for Reviewing the Grievances Related to the Advocacy and Legal Consultancy Profession in the Emirate of Dubai

Does hereby issue this Resolution:

Article (1)

Formation of the Committee

A. "The Committee for Reviewing the Grievances Related to the Advocacy and Legal Consultancy Profession in the Emirate of Dubai", referred to hereinafter as "the Committee", shall be formed in the Department and comprised as follows:

6-	Legal Counsel/Haitham Abdel Monem Nafea	Member

B. Membership of the Committee shall cease on 31st of December every year. Members of the Committee shall continue to perform their duties if a resolution to re-constitute it has not been issued by the Director General of the Department.

Article (2)

Functions of the Committee

- A. The Committee shall decide on grievances in terms of actions and decisions issued by the Department based on the provisions of the aforementioned Executive Council Resolution No. (22) of 2011, bylaws and decision issued by virtue of that Resolution relevant to the regulation of advocacy and legal consultancy profession in line with the legislation in force in the Emirate of Dubai.
- B. The decision issued by the Committee shall be final.

Article (3)

Work Mechanism of the Committee

- Meetings of the Committee shall be convened at the invitation of its Chairperson whenever needed. A.
- Hearings of the Committee are valid if the majority of its members are present. Those hearings may be chaired by the B. member in attendance who has the highest years of service with the Department.
- C. The Committee shall issue its reasoned decisions by a majority vote of members in attendance. In the event of a tied vote, the chair of the hearing shall have the casting vote.
- Committee's decisions shall be recorded in minutes of meetings to be signed by the Chair of hearing and members in D. attendance.

Article (4)

Translation Work

Advocates and Legal Consultants Affairs Directorate shall coordinate with Legal translation Section to assign a translator to provide the Committee with translation as assigned by the Chair of the hearing in a manner that ensures the proper workflow of the hearing.

Article (5)

Rapporteur of the Committee

Rapporteur of the Committee shall send invitations to attend the Committee hearings, prepare its agenda, record its minutes of hearings, follow up the implementation of its decisions and perform any other duties assigned to them by Chairperson of the Committee.

Article (7)

Supersession

This Resolution supersedes the aforementioned Administrative Resolutions Nos. (5) of 2023 and (11) of 2025.

Article (8)

Commencement

This Resolution shall come into force on the date of its issuance and be communicated to whomever is necessary for its implementation.
