

Administrative Resolution No. (34) of 2025

Appointing Members of the Grievance Committee against Decisions of the Professional Conduct Committee of Advocates and Legal Consultants

The Director General of the Government of Dubai Legal Affairs Department,

After perusal of:

Administrative Resolution No. (54) of 2022 Concerning the Regulation of Disciplinary Accountability of Advocates and Legal Consultants in the Emirate of Dubai;

Administrative Resolution No. (6) of 2025 Appointing Members of the Grievance Committee against Decisions of the Professional Conduct Committee of Advocates and Legal Consultants;

Administrative Resolution No. (28) of 2025 Appointing Members of the Professional Conduct Committee of Advocates and Legal Consultants; and

Administrative Resolution No. (29) of 2025 Appointing Members of Subcommittees of the Professional Conduct Committee of Advocates and Legal Consultants,

Does hereby issue this Resolution:

Article (1)

Formation of the Committee

A. **"The Grievance Committee against Decisions of the Professional Conduct Committee of Advocates and Legal Consultants"** shall be comprised of two subcommittees, referred to hereinafter as **"the Subcommittee"**, as follows:

First: The **First Subcommittee** of the Grievance Committee against Decisions of the Professional Conduct Committee of Advocates and Legal Consultants shall be comprised as follows:

1-	Dr. Lowai Mohammed Khalfan Belhoul	Chairperson
2-	Legal Counsel/ Ahmed Mohammed Ezzat	Vice Chairperson
3-	Legal Counsel/ Mohammed Feteiha Korra	Member
4-	Legal Counsel/ Ibrahim Habashy Hassaballa	Member
5-	Legal Counsel/ Reda Mahmoud Elsayed	Member

Second: The **Second Subcommittee** of the Grievance Committee against Decisions of the Professional Conduct Committee of Advocates and Legal Consultants shall be comprised as follows:

1-	Dr. Lowai Mohammed Khalfan Belhoul	Chairperson
2-	Legal Counsel/ Mohammed Feteiha Korra	Vice Chairperson
3-	Legal Counsel/ Ahmed Mohammed Ezzat	Member
4-	Legal Counsel/ Mohamed Farouk Gadalla	Member

5-	Legal Counsel/ Haitham Abdelmonem Nafea	Member

- B. Membership of the Subcommittee shall cease on 31st of December 2026. Members of the Subcommittee shall continue to perform their duties if a resolution to re-constitute it has not been issued by the Director General.
- C. Each Subcommittee shall perform duties and functions of the Committee and shall be subject to rules and provisions of the Committee as stipulated by the aforementioned Administrative Resolution No. (54) of 2022.

Article (2)

Work Mechanism of the Subcommittee

- A. Meetings of the Subcommittee shall be convened at the invitation of its Chairperson or Vice Chairperson in the absence of the Chairperson.
- B. Meetings of the Subcommittee are valid if the majority of its members are present, provided that Chairperson or the Vice Chairperson is present.
- C. The Subcommittee shall issue its decisions by the majority vote of its members in attendance. In the event of a tied vote, the chair of the meeting shall have the casting vote. Decision issued by the Subcommittee should be justified.
- D. Subcommittee decisions shall be recorded in minutes of meetings to be signed by the Chair of the meeting and members in attendance.
- E. All discussions of the Subcommittee shall be confidential and should not be disclosed. It shall not be permitted to extract a copy of the information recorded in the minutes of meetings unless there is a decision issued by its Chairperson.

Article (3)

Supersession

This Resolution supersedes the aforementioned Administrative Resolution No. (6) of 2025.

Article (4)

Commencement

This Resolution shall come into force on the date of its issuance and be communicated to whomever is necessary for its implementation.
